

# House passes FY2016 budget conference agreement—Senate up next

Following a House and Senate conference to work out the differences between each chamber's Fiscal Year 2016 budget resolutions considered in March, the House on Thursday passed S. Con. Res. 11 by a vote of 226-197. While the House plan originally proposed making cuts to a widerange of programs by instructing every House committee to find savings through budget reconciliation, conferees ultimately agreed to the Senate's plan. ### Issa re-introduces his door delivery reduction bill

On April 16, Rep. Darrell Issa (R-CA) introduced H.R. 1837, the Secure Delivery for America Act. If passed, this bill would require the Postal Service to eliminate door delivery for 15 million addresses over the next 10 years by forcing 1.5 million households and businesses each year to convert from door delivery to curbside or cluster-box delivery.
