If delegates do not have the opportunity to schedule an appointment in advance, appointments may be made on-site based on available times.

## **Proposed amendments to the NALC Constitution**

he following proposed amendments to the NALC Constitution will be considered by the delegates to the 67th Biennial Convention in Anaheim. Proposed new language is printed in bold; strike-through indicates proposed language to be deleted. The Constitution is available on the NALC website, NALC.org. Look under About NALC>Facts & History>Union Structure.

#### **NALC Constitution**

### Time and Place of Conventions and Special Meetings

Amend Article 3, Section 4 (b) as follows:

Sec. 4 (b). The National President shall once each year, except in the year of the National Convention, call a national conference. This conference shall be held during the same time frame as the National Convention (between the 4th of July and three full weeks in August). This conference shall be voluntarily attended by only State and Branch Presidents or their designees, with their expenses to be borne by the State Association or Branch represented.

#### **Resolutions**

Amend Article 12 as follows:

Section 1. Any Branch in good standing or any State Association may, at any time, forward to the National Secretary-Treasurer resolutions properly attested by their President and Secretary-Treasurer for consideration by the appropriate Union authority. Such resolutions must be in duplicate, and each shall be on a separate sheet of paper. Resolutions pertaining to the National Working Agreement, which should, insofar as possible, identify the Article and Section to be changed, shall be forwarded to the Chief Spokesman of the NALC Negotiating Team; those pertaining to legislation shall be forwarded to the NALC Director of Legislation: and all others shall be forwarded to the NALC Executive Council for their consideration and appropriate action. Those appropriate authorities shall report to the National Convention on all such resolutions and the action taken thereon.

Section 2. All resolutions to be placed before the National Convention shall be posted on the NALC website at least one (1) month before the Convention.

#### Constitution for the Government of Subordinate and Federal Branches

#### Charges

Amend Article 10, Section 3 as follows:

Sec. 3. The president, or if the president be the

person against whom charges are made, the vice president, shall then appoint a committee of three disinterested members, who shall forthwith summon the parties, hear and take down or cause to be taken down or recorded, the testimony and/or documentary evidence presented. It shall be the duty of the committee to find the true facts and report to the Branch. The parties are entitled to be heard by the committee, to present evidence, and to crossexamine all witnesses who make statements to the committee, but rules of evidence and rules of judicial procedure need not be observed. Should the charging party refuse to meet with the committee, the charges will be considered to be abandoned and require no further action by the branch. The committee, after completing its fact-finding duty will present to the Branch a written report of the facts elicited, and immediately thereafter disband and be eligible to vote. The Branch shall then decide, by simple majority vote, the issue of whether or not the facts, as found by the committee, sustain the charge. The charged party is entitled to defend himself/herself before the Branch immediately before the vote is taken, except in those instances when the charged party has refused to meet with the committee he/she will have waived his/her right to defend himself/herself before the Branch immediately before the vote is taken. If the Branch decides that the facts sustain the charge, then the Branch shall entertain a motion to fix the penalty, if anv be required.

#### Constitution and General Laws of the United States Letter Carriers Mutual Benefit Association

### Law 1–Qualifications of Applicants for Membership

Amend Law 1, Section 1 as follows:

Section 1. An applicant for admission to membership in the MBA must be a letter carrier or other nonsupervisory employee of the Postal Career Service who is a member in good standing of the NALC, or the spouse, child, **step-child**, grandchild, **step-grandchild**, great grandchild, **or step-great grandchild** of a member of the NALC. Employees of the NALC and its subsidiaries, their spouse and children are also eligible applicants for membership in the MBA.

# Time limits waived

**The NALC and the Postal** Service have agreed to a waiver of time limits during August for all grievances because of the union's 67th Biennial Convention, which takes place in Anaheim, California August 9-13.

The agreement, signed by NALC President Fred Rolando and USPS Vice President-Labor Relations Doug Tolino, covers all parties at the local, regional and national levels for the entire month of August, not just the week of the convention. ⊠
