Leading by example Latest graduates challenged to help save their Service

etter carriers will depend on the next generation of NALC leaders to weather a difficult time of transition. Some of those future leaders may emerge from the group that graduated from the NALC Leadership Academy on May 12 after completing several months of in-depth training.

Presiding over the graduation ceremony, NALC Vice President George Mignosi told the 30 graduates that they face challenges unlike any leaders before them.

"The Postal Service is struggling with a transition of historic proportions," said Mignosi, "and it's hobbled by its own management. That's why our leaders need to step up. You are the people who know how the Postal Service really works and what needs to get done, and now you are even better equipped to lead the charge." Some graduates may be called upon to use their leadership abilities as branch, regional or national officers, but Mignosi stressed that just standing up and leading by example were essential first steps. "Your impact can be felt just by talking to your fellow letter carriers, by leading lobbying efforts, by writing letters to the editor, by encouraging support for COLCPE," he said. "When politicians and the public really understand what's happening and hear our message, they will support us, but we have to reach them at every level."

Since 2005, the Leadership Academy has given scores of letter carriers the opportunity to sharpen their communication and leadership skills and their expertise on union affairs. The students cram a great deal of learning activities into a short amount of time at the Academy. With the help of branch officers

and national business agents who act as their mentors, students—two from each of NALC's 15 regions—discuss a host of issues in both day and evening sessions.

During their three one-week, on-site sessions at the National Labor College campus in Silver Spring, Maryland, students cover issues like dispute resolution, branch finances, retirement, the National Agreement, DOIS, route adjustment, negotiating strategies, written and verbal communication, running campaigns, and motivating others. In between the weeks in the classroom, the students reinforce their learning by completing take-home projects and presentations.

"My sincere thanks go to the letter carriers who devote their efforts to bring their experience and ideas to the table and who do the hard work necessary to convey our union, and our Service, to a new generation," said NALC President Fred Rolando. "Thanks also to their mentors, who recognized the potential within these men and women and who are passing on their knowledge. "The Leadership Academy continues to enhance the capabilities of our future leaders—and gives them a taste of what it takes to serve in a role that affects so many letter carriers and their families," Rolando said.

A new batch of Leadership Academy participants begins its work this month *(see list below)*, starting with their first week-long session in Silver Spring, with two more sessions in October and December to follow.

Rolando praised the incoming students for their commitment and willingness to sacrifice their time in service to their fellow letter carriers.

"We receive applications from a great deal of highly qualified candidates for the Leadership Academy, and it's not easy to pick 30," Rolando said. "But the process of choosing always makes me confident about the future of our union,

because it's clear many devoted letter carriers are eager to go the extra mile and develop their leadership talents for the good of us all."
