# A better tomorrow Graduates asked to put their skills to work today

ALC Executive Vice President Timothy C. O'Malley called on the graduates of the 11th Leadership Academy class to remember the people they represent as they rise to the challenges of today and tomorrow. His remarks came as he presided over the graduation ceremony on May 13 at the National Labor College in Silver Spring, MD, a few miles north of Washington, DC.

The event capped several months of intensive training on the skills necessary for union members to become effective leaders. Under the tutelage of their mentors—established NALC leaders such as branch presidents or national business agents—the students combined three separate weeks of classroom learning at the labor college with take-home assignments and special projects.

The 30 participants add their names to an ever-lengthening list of success-

ful graduates of the academy, which was created in 2005. Retired NALC Executive Vice President Jim Williams and Jim Korolowicz, a former national assistant secretary-treasurer, collaborate with Director of Education Jamie Lumm to coordinate a well-rounded and effective curriculum. The trio also taps a number of NALC officers and Headquarters staff members and experts to prepare lectures and lessons on a wide variety of topics.

During the group's final week in Washington last month, students took part in often lively discussions on such subjects as JARAP and COR, strategic planning, workers' compensation, retirement issues, contract enforcement, negotiating techniques, the NALC Health Benefit Plan, Mutual Benefit Association and recruiting others to step up as union leaders.

And to make the most of their time in the Washington area, Academy students also came together after their dinner breaks to learn about conducting oneon-one campaigns, interest-based dispute resolution, and group dynamics.

Each week of the Academy also includes an ongoing emphasis on effective written and verbal communication skills in such forums as membership meetings, awards ceremonies and dinners, as well as written reports and oral presentations about their "take-home" projects.

"You've done great work here," O'Malley said, "but now you need to take back what you've learned and utilize it. Don't let anyone deter you."

He called on them to help during these difficult times when Congress is looking into union contracts, like the recently ratified APWU agreement. Their work will also be needed to help the Postal Service weather the current fianancial hardships.

"It's with your leadership that this union and the Postal Service will survive," he said.
