Penalty overtime exclusion

As referenced in Article 8, Sections 4 and 5, of the USPS-NALC and **USPS-APWU** national agreements. the December period (during which penalty overtime regulations are not applicable) consists of four consecutive service weeks. This year, the December period begins Pay Period 26-13—Week 1 (Nov. 30, 2013)—and ends Pay Period 01-14-Week 2 (Dec. 27, 2013). PR

TSP and FSA clarifications

Eligible postal employees may enroll in or make changes to a Thrift Savings Plan (TSP) account at any time of the year. Based on information from a Postal Service document, an article in last month's issue of The Postal Record reported that changes to TSP accounts could be made only during an open season period.

Additionally, the FSA open season ends on Dec. 22, not Dec. 9, as OPM has reported and as was printed in the November Postal Record. PR

CCAs converted to full-time career status

ursuant to the memorandum of understanding Re: Residual Vacancies—City Letter Carrier Craft (M-01824), the first wave of city carrier assistant (CCA) conversions to fulltime career status took place on Nov. 2.

While the exact number of conversions that took place on that date had not yet been finalized as of press time, NALC estimates about 1,500 CCAs, most of whom had served multiple years as transitional employees prior to becoming CCAs, were converted to full-time career status to fill vacant full-time letter carrier jobs.

By virtue of the memorandum of understanding Re: Sunday Delivery—City Carrier Assistant Staffing (M-o1826), those CCAs who served as city carrier transitional employees directly before their CCA appointments will not serve a probationary period as fulltime career letter carriers.

M-01824 lays out a series of steps to fill residual vacancies in the city letter carrier craft. Vacancies are first filled by assignment of unassigned regulars and conversions of part-time flexibles to full-time status in the same installation as the vacancy.

Next, the vacancies are posted for a 21-day period in eReassign. Only career letter carriers may apply for such vacancies. Requests are considered in the order they

are received and include those reassignment requests pending in eReassign. Requests from PTF letter carriers are acted on without regard to normal transfer considerations. Additionally, PTF letter carriers who transfer under M-o1824 have retreat rights back to the first residual vacancy that occurs in their original installation when there are no PTF city letter carriers on the rolls in that installation.

If the vacancies remain, they are filled by CCA conversions to full-time career status and a limited number of reassignments from employees in other crafts (if employees from another craft request reassignment). As vacancies continue to be filled through these steps in M-o1824, more CCA conversions should take place in the coming weeks and months.

Those CCAs newly converted to full-time career status have access to the full slate of benefits provided to career letter carriers. This includes health benefits, vision and dental benefit programs, group life insurance and long-term care insurance, just to name a few. Additionally, they are part of the Federal Employees Retirement System (FERS) and are automatically enrolled in the Thrift Savings Plan (TSP), including receiving matching TSP contributions from the Postal Service.

New full-time career letter carriers also earn annual and sick leave in accordance with Article 10 of the National Agreement and may participate in the local leave program. Local leave provisions are covered in the local memorandum of understanding (LMOU). For information, please contact your shop steward or a branch officer. PR

CCA relative standing

ity carrier assistants (CCAs) are credited with something similar to seniority called relative standing. Relative standing is determined by the original CCA hire date in an installation. For those CCAs who were transitional employees (TEs) before being hired as CCAs, all time served as a TE after Sept. 29, 2007, is added.

In the event that a CCA stops working in one installation and begins work in another, relative standing credit earned in one installation as a CCA does not transfer over to another. However, relative standing credit earned as a TE always transfers with the CCA, no matter where he or she worked.

Relative standing is important for several reasons. When CCAs are converted to full-time career status within an installation, the CCA with the most relative standing in that installation is the first one to be converted to full-time career status.

Relative standing also comes into play if the Postal Service needs to separate a CCA due to lack of work or if the Postal Service decides to not reappoint a CCA for operational reasons. In both of these circumstances, the CCA with the least relative standing in that installation is separated first.

CCAs separated for lack of work or due to operational circumstance will be given preference for reappointment ahead of other CCAs with less relative standing in the installation if the need for hiring arises within 18 months of their separation.

Inspection Service offers tips for dealing with mail robberies

very year, the **United States** Postal Inspection Service investigates about 100 robberies of postal employees or facilities. Its No. 1 message to carriers who face this threat every time they take up their satchels: "You are your most important delivery."



The Postal Inspection Service is empowered by Congress "to investigate postal offenses and civil matters relating to the Postal Service." Inspectors carry firearms, make arrests, execute federal search warrants and serve subpoenas.

To help carriers prepare for the possibility of being robbed, the Inspection Service created a brochure and video on what they should do if confronted or threatened on their routes.

"If you notice a suspicious person, treat it seriously, even if you don't see a weapon or feel like you're in danger," the brochure states. "The most important delivery of the day is always at the end of your route. Deliver yourself home to those who are dear to you, by playing it safe."

The brochure gives six useful tips for things letter carriers can do to protect themselves.

ydia Ray, a member of Garden Grove, CA Branch 1100, was struck and critically injured while delivering mail on Saturday, Oct. 19, in the city of Compton.



According to KABC-TV, the hit-andrun driver slammed into a parked car before ramming his vehicle into the back of Ray's LLV, throwing her from her vehicle. She was taken to St.

Francis hospital, where she remained in the ICU for several days before being transferred to a regular room.

A police spokesman said Ray, a 20year postal veteran, sustained broken legs, cuts to her arms and internal injuries. Authorities are searching for the driver, who witnesses say fled the scene.
