



## From the Trustee

The March edition of *The Postal Record* featured the 50th anniversary of Nalcrest on its cover and included inside stories and photos from the 50th anniversary festivities and events. It also highlighted a benefit for NALC members to look forward to when they decide to retire—Nalcrest itself. The article was such a success, grand standing for the Nalcrest Foundation Inc., that many members made inquiries and apartment rentals peaked.

The April edition of *The Postal Record* then allowed Nalcrest Trustee Don Southern to speak about the dozen short-term rental Nalcrest “guest apartments” available 365 days a year, starting at \$50 a day plus state and county taxes. The daily rates get lower the longer you stay. Unlike the yearly apartment rentals, these fully furnished apartments are operated on a hotel/motel concept. They are open to the public and not exclusively for NALC members. The guest apartments do fill up fast and require a deposit, so don’t wait until the last minute to book one.

NALC members seeking additional information on yearly leases or short-term rentals should call the Nalcrest office between 9 a.m. and 4 p.m. E.T., Monday through Friday, at 863-696-1121. As a reminder, Nalcrest is a no-pet facility and is not an assisted-living community.

On April 1, the Nalcrest trustees held their annual meeting with the Nalcrest residents to report on past and future items affecting Nalcrest. NALC President Rolando chaired the meeting. It was the beginning of another 50 years of Nalcrest.

Finally, please do not show up at Nalcrest to move in or to stay in a guest apartment without first calling for availability and arranging to sign a lease or a rental agreement. This is not a good idea. But do pick up the phone today and make plans to start enjoying Nalcrest!
