From July to December, the attendees will combine three separate weeks of classroom learning near NALC Headquarters in Washington, DC, with take-home assignments and special projects. The Leadership Academy incorporates classroom instruction, group projects and individual assignments designed to develop and enhance the skills necessary for future leaders of the NALC. At the Academy, students engage in lively discussions on such topics as labor history, organizing, and the union's legislative agenda. They learn about branch

financial responsibilities, contract administration, route adjustments and workers' compensation. They participate in exercises designed to enhance their teaching, public speaking, negotiation and writing skills.

The attendees will also learn under the tutelage of mentors—established NALC leaders such as branch presidents or regional administrative assistants. After the three separate weeks of classroom experience near Headquarters, they will also gain experience working in their regional offices.

"If they put their all into this program, they will leave with skills and confidence they may never have thought they would achieve, thanks to this rigorous but rewarding program," NALC President Fredric Rolando said. PR
