NALC announces e-Activist and LCPF award categories

s NALC's 70th biennial national convention draws closer, the Department of Legislative and Political Affairs is pleased to announce updated e-Activist and Letter Carrier Political Fund award categories. These awards recognize the outstanding participation of NALC members in our efforts to advocate for the issues most important to letter carriers on Capitol Hill and help elect lawmakers who will deliver our message to Washington.

Because of the momentum we've built, lawmakers know who we are and what we do: put boots on the ground. We're proud to recognize those who have gone above and beyond in their advocacy.

The e-Activist awards granted at the national convention will reflect data on file on July 15, 2016. The LCPF awards granted at the national convention will reflect efforts from July 15, 2014, through July 15, 2016. The award categories include:

e-Activist Network Awards

Branch e-Activists: Branches will be divided into three categories based on the number of members (e.g., under



249, 250 to 999, and 1,000 or more). The branch with the highest number of e-Activists in each category will be recognized.

State e-Activists: State associations will be divided into small, medium and large groups (e.g., 1 to 1,999, 2000 to 7,499, and 7,500 or more) and awarded for the highest e-Activist participation in each category.

Regional e-Activists: NALC's 15 regions will be divided into small, medium and large groups (e.g., under 14,999, 15,000 to 19,999, and 20,000 or more) and awarded for the most e-Activist participation in each category.

Letter Carrier Political Fund awards



Branch LCPF contributions: Branches will be divided into three categories based on the number of members (e.g., under 249, 250 to 999, and 1,000 or more members). The branch with the highest per capita contribution in each category will be recognized.

State LCPF contributions: The state association with the highest per capita contribution will be recognized.

Branch member LCPF contributions: Branches will be divided into three categories based on the number of members (e.g., under 249, 250 to 999, and 1,000 or more). The branch with the highest percentage of members contributing to LCPF in each category will be recognized.

State member LCPF contributions: The state association with the highest percentage of members contributing to LCPF will be recognized.

NALC appreciates the hard work that letter carriers invest into ensuring that we elect those friendly to our issues. If you have any questions about the categories, contact the Legislative and Political Affairs Department.

Note: By making a contribution to the Letter Carrier Political Fund, you are doing so voluntarily with the understanding that your contribution is not a condition of membership in the National Association of Letter Carriers or of employment by the Postal Service, nor is it part of union dues. You have a right to refuse to contribute without any reprisal. The Letter Carrier Political Fund will use the money it receives to contribute to candidates for federal office and undertake other political spending as permitted by law. Your selection shall remain in full force and effect until cancelled. Contributions to the Letter Carrier Political Fund are not deductible for federal income tax purposes. Federal law prohibits the Letter Carrier Political Fund from soliciting contributions from individuals who are not NALC members, executive and administrative staff or their families. Any contribution received from such an individual will be refunded to that contributor.
