I have been a part of the NALC for 34 years, almost my entire adult life. I started my postal career as an LSM clerk in 1981 and became a letter carrier in 1982. I was raised in a union family, so I understood the

importance of unions to working families, but it was my brother who really instilled in me why it was so important to be a union member. As we all know, unions form the cornerstone of our country, helping the American dream to become a reality by representing their members and the working class.

I grew up believing in the union, but I soon found out after joining the NALC that I wanted to represent the members and be a voice in the union for myself and my brothers and sisters. In 1984, I became a shop steward in my station, which later led to my being appointed as an area steward for Garden Grove, CA Branch 1100 and then trained in 1999 as an arbitration advocate.

Prior to becoming an arbitration advocate, in 1993, the late NALC President Emeritus Vincent R. Sombrotto appointed me as an NALC Joint Route Inspection Team coordinator for San Diego District North. While doing this, I concurrently served on the Employee Involvement Local Joint Steering Committee and as the NALC's DPS coordinator.

In 2001, I was elected by acclamation as a full-time officer for Branch 1100, holding the office of vice president through 2005, when NALC President Emeritus Bill Young

appointed me to the position of regional administrative assistant for Region 1. While serving in my role as RAA, in addition to my normal day-to-day duties, I received OWCP training and held key roles in NALC's joint ventures with the Postal Service, including direct oversight of the various joint route inspection processes.

In 2010, I was elected by acclamation as national business agent for Region 1 at the national convention in Anaheim, CA. As the NBA for Region 1, which has 38,000 members, I oversaw the grievance procedure, including arbitration reviews and scheduling; the region's many dispute resolution teams; the intervention process; the training needs of the region's members and union representatives; and the joint route inspection processes, just to name a few of my duties.

As NALC's director of city delivery, I will continue to represent the nation's letter carriers and find ways to improve and fairly adjust their routes to as near eight hours as possible. I will continue to represent city carriers on workroom floor issues, such as making sure that the mobile delivery devices used to transmit and scan data in real time are working efficiently. I will continue to assist with CCA contractual issues that affect new CCAs and experienced CCAs alike, and I will continue to provide our membership with education regarding city delivery resources.

As new Executive Vice President Brian Renfroe stated in his article in last month's *Postal Record*, it is important that we continue to find new avenues to increase revenue for the Postal Service, such as continuing with non-traditional services like grocery delivery, same-day parcel delivery, and Sunday and holiday parcel delivery. My goal is the same, and I will continue this search to help the Postal Service grow and, in turn, provide work and job security for letter carriers.

I consider it a great honor to continue to serve, stand with and represent my brothers and sisters of the NALC as the director of city delivery.
