#### Open Season: Nov. 12-Dec. 10

Although the weeks have slipped away, and the Open Season is coming to a close, there are still a few days left for you to join the HBP. While maintaining low premiums, we offer a comprehensive and affordable health care package for 2019.

### Qualifying life events outside of Open Season

If you have a qualifying life event (QLE) such as conversion to career status, marriage, divorce or the birth of a child outside of the Federal Benefits Open Season, you may be eligible to enroll in the FEHB program, change your enrollment or cancel coverage. #### 2019 Health Benefit Plan brochure

Below you will find a summary of the 2019 benefit changes. Detailed information can be found in the official 2019 HBP brochure, or on our website at nalchbp.org.

Changes to the Plan:

- We now require prior authorization for genetic testing.
- We now cover gender reassignment surgery for a diagnosis of gender dysphoria.
- We now offer lower co-payments and co-insurance for medication used to treat hypertension, diabetes and asthma.
- We now cover one preventive medicine counseling visit associated with a low-dose CAT scan.
- We now cover pre-eclampsia screening for pregnant women.
- We now cover obesity screening for adolescents and children 6 years of age and older.
- We now cover screening for post-partum diabetes mellitus after pregnancy.
- We now cover screening for urinary incontinence under Well Woman care.
- We now cover the Shingrix vaccine for the prevention of herpes zoster or shingles.
- We have updated the medical requirements to qualify for statin medication.
- We now cover skin cancer prevention counseling for children age 6 months through 21 years.
- We now offer the Transform Diabetes Care Program under "Wellness and Other Special Features."
- We no longer apply manufacturers' discounts on specialty medications to the patient's deductible or out-of-pocket maximum.

Changes to our High Option Plan only:

- Your share of the non-Postal premium will increase for Self Only, Self Plus One and Self and Family options.
- We no longer require prior authorization for the shingles vaccine.
- We now cover speech-generating devices, limited to \$1,250 per year.
- You now pay \$20 for a spinal or extraspinal manipulation rendered by a PPO provider. Previously you paid 15 percent.

Changes to our Value Option or Consumer-Driven Health Plans:

- Your share of the non-Postal premium will increase for Self Only, Self Plus One and Self and Family options.
- We now cover the initial office visit or consultation to assess a patient for acupuncture treatment.
