## There's still time to contribute through CFC

ince the inception of the Combined Federal Campaign (CFC) in 1961, the federal workplace charitable giving program has raised more than \$8.3 billion for charity. As federal employees, letter carriers are eligible to participate in the CFC-however, there is a limited time to contribute. The last day to register during the 2019 Open Season is Jan. 12, 2020.

The CFC allows letter carriers to make charitable donations using deductions from their paychecks. During Open Season, employees may make pledges to the eligible non-profit organizations of their choosing.

After selecting from a list of more than 2,000 eligible charities, carriers may then choose their desired donation amount for each organization. which will be automatically deducted from their paychecks every pay period and sent to the charities. Donations from retired letter carriers are taken out of their annuity payments.

The CFC list includes three charities with close ties to NALC:

The Muscular Dystrophy Association (MDA) is NALC's only official charity. It is the world's leading nonprofit health organization sponsoring research, treatments and improved

technological assistance for individuals with neuromuscular diseases. MDA research grants support about 150 research projects worldwide, as well as camps and activities for children with neuromuscular diseases. For more information, go to mda.org.

The Postal Employees' Relief Fund (PERF) provides small relief grants to assist active and retired postal employees whose primary residence has been destroyed or left uninhabitable by a major natural disaster or house fire. The fund helps qualifying victims re-establish residence and replenish necessities in the

aftermath of these disasters. The charity is run by the four postal employee unions and three management organizations; members support PERF through voluntary donations. Information and applications for as-
